1. LEGAL TERMS: By submitting an Entry (as defined herein) to the GE Healthcare ("GEHC") Novii Call for Research Proposals (the "CFP") you are agreeing to be bound by the following legal terms ("Official Rules").

2. SUPPORTERS; ADMINISTRATOR: The CFP is administered by GEHC, , 9900 Innovation Drive, Wauwatosa, WI 53226.

3. GENERAL INFORMATION: Research proposals are accepted based on scientific, medical, and health economic merit and alignment with GE Healthcare's strategic research needs and shall in no way be linked to any commercial relationship or the value of any past, present or future commercial deal.

Participation is subject to all federal, state and local laws and regulations. Void where prohibited or restricted by law. Multiple entries are permitted and there is no limit to the number of entries which can be submitted. Each entry will be reviewed independently. Multiple individuals or entities may collaborate to submit a single entry, but a single individual must be designated as an "Official Representative" for each entry. Investigators are encouraged to submit entries for all research programs that align with the goals of this CFP.

You are solely responsible for checking applicable laws and regulations in your jurisdiction before participating in the CFP to make sure that your participation is legal. You are responsible for abiding by your employer's policies regarding participation in the CFP. You further agree and acknowledge that you are solely responsible for the security, accuracy and use of your Account.

Each CFP registrant is referred to as an "Entrant" or "Applicant" in these Official Rules and as "Entrant" or "Applicant".

8. ENTRY GUIDELINES AND REQUIREMENTS: An entry may address on-label or investigational CFPs, including screening, diagnosis, treatment guidance, and/or monitoring.

Your entry will be evaluated by an internal research committee. Entries that best meet the scientific, medical, and health economic merit and alignment with GE Healthcare's strategic research needs as determined by the committee will be selected to receive research support.

Entrants are responsible for ensuring that all aspects of any research being proposed is compliant with Good Clinical Practice (GCP) guidelines, where applicable, as well as all local and federal regulations including HIPAA. Local IRB and IACUC approval at the time of submission is not required.

9. INTELLECTUAL PROPERTY: By simply submitting an entry and participating in this CFP, you are not granting GEHC any rights to any existing patents or future patents related to the technology described in your entry. However, except for portions of any entry covered by an issued and enforceable patent you may own, GEHC shall have the unrestricted right to use, reproduce, distribute, perform, display or create derivative works based upon any submitted ideas or materials and associated intellectual property rights relating to your entry (collectively "Entry IP"), and to allow others to do the same. You agree that this consent is perpetual and cannot be revoked. You agree that nothing in the Official Rules grants you a right or license to use the GEHC name or any GEHC trademark or service mark. THE AGREED UPON PLAN FOR GUIDED EQUIPMENT OR FINANCIAL SUPPORT WILL BE BASED UPON WINNER'S RECOMMENDATIONS AND MUST, AT A MINIMUM, SET FORTH (A) THE SCOPE, CLINICAL RESEARCH OBJECTIVES, CLINICAL RESEARCH RELATIONSHIP, TIMELINE AND DELIVERABLES FOR THE TWELVE (12) MONTHRESEARCH PERIOD; (B) AN EXPLANATION OF THE NECESSARY CONTRIBUTORS AND THEIR ANTICIPATED RESPONSIBILITIES AND DELIVERABLES; (C) A PROJECT BUDGET FOR UTILIZATION OF THE EQUIPMENT OR FINANCIAL SUPPORT, AND (D) TERMS FOR SUBMISSION OF A FINAL REPORT AT THE CONCLUSION OF THE RESEARCH PERIOD WHICH WILL SUMMARIZE RESULTS AND COMPARE OUTCOMES TO THE INITIAL PROPOSED RESULTS FOR THE RESEARCH STUDY (THE "AGREED UPON PLAN"). MANY OF THE INPUTS FOR THIS AGREED UPON PLAN WILL BE DRAWN FROM YOUR ENTRY.

11. PRIVACY: By entering this CFP, you acknowledge and agree that GEHC will have access to and use of any personal data provided in connection with your entry for the purposes described in these Official Rules, and as governed by the Privacy Policy posted on the GE Website http://www.ge.com/privacy. You further agree that GEHC may share the personal data provided in connection with your entry with designated third parties for purposes described in these Official Rules.

12. CONFIDENTIALITY: Since GEHC does not wish to receive confidential information, nor hold any submitted materials "in confidence," it is agreed that, with respect to your entry, no confidential relationship or obligation of secrecy is established between GEHC and you, the company or entity you

represented when submitting an entry, or the owner of any part of your entry. Moreover, you acknowledge and agree that, as such, GEHC and their respective affiliates, subsidiaries, parents, contractors, and licensees and other business partners (as well as their respective successors and assigns) are not under any obligation of confidentiality with respect to the entry or any information contained therein, will have no obligation or liability to you or any other person or entity for the disclosure or other utilization of such entry or information, and will be free to use such entry or information for any purpose whatsoever. GEHC shall have no liability or responsibility for use by any other individual or entity of any aspect of your entry.

13. WARRANTIES: By submitting an entry, you represent and warrant that all information in your entry and all information that you submit via the CFP Research Manager is true and complete to the best of your knowledge, that you have the right and authority to submit the entry and disclose the information therein on your own behalf or on behalf of the persons and entities that you specify within the entry, and that your entry (and the underlying technology/method/idea described in the entry): a. is your own original work and representative of your capability, or is the original work of your team submitted with the permission of all team members with full and proper credit given within your entry; b. contains NO confidential information or trade secrets (yours or anyone else's); c. does not, to the best of your knowledge, violate or infringe upon the patent rights, industrial design rights, copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity; d. contains no malicious code, such as viruses, malware, timebombs, cancelbots, worms, Trojan horses or other potentially harmful programs or other material or information; e. does not and will not violate any applicable law, statute, ordinance, rule, regulation, confidentiality agreement or other agreement; f. triggers no reporting, or royalty or other obligation to any third party; and, g. has not won any other prize or award.

Receipt of research support does not convey licensure, royalty, or other financial compensation, unless otherwise mutually agreed in writing between you and GEHC. You are responsible for all taxes and reporting related to any research support that you receive as part of the CFP.

Whether or not your entry is selected to receive research support depends on how your entry compares to the other entries submitted when evaluated based on the Judging Criteria.

Novii Products and/or technologies mentioned may be subject to government regulation and may not be available in all countries. Device shipment in certain countries may not be possible.

16. LIMITATION OF LIABILITY: By participating in the CFP, you agree to release, indemnify and hold harmless GEHC and their respective affiliates, subsidiaries, parents, contractors, and licensees and other business partners, and advertising and promotions agencies, as applicable, and each of their respective agents, representatives, officers, directors, shareholders, and employees and successors and assigns (collectively, "GEHC Entities") from and against any injuries, losses, damages, claims, actions and any liability of any kind (including attorneys' fees) resulting from or arising out of your participation in, association with or submission to the Event (including any claims alleging that your entry infringes, misappropriates or violates any third party's intellectual property rights).
