


GE HealthCare is committed to upholding the confidentiality and integrity of systems and data during the installation process. Our ISMS is designed to support these efforts by implementing the full range of ISO 27001, 27018, and 27701 controls, covering employee actions and tools for enhanced protection.



#### **Education**

GE HealthCare provides both on-site and remote training to your personnel if they use our products. When providing training, the GE HealthCare ISMS covers activities in which there could be visibility to sensitive data and provides the appropriate level of protection.




#### Maintenance
